Depositary Notification

Proposal for corrections to the edition of RID in force since 1 January 2025
(Annex to Appendix C to the Convention)



In his capacity as depositary of the Intergovernmental Organisation for International Carriage by Rail (OTIF), the Secretary General notifies the following:

In the German, English and French versions of the edition of RID in force since 1 January 2025 (Annex to Appendix C to the Convention), several obvious errors were noted. The proposed corrections are compiled in the annex and are also published on OTIF's website under Legal Texts > Depositary Notifications > 2025.

Unless there are any objections to these corrections from a Member State which has not made a declaration pursuant to Article 42 § 1, first sentence, that it does not apply RID (Appendix C to the Convention), the Secretary General will make the proposed corrections to the authentic French, German and English texts of RID. Any objections should be communicated to the Secretary General within one month from the day of this notification, i.e. by 18 August 2025. Once this deadline has expired, we will inform you of the situation.
