The purpose of processing your personal data

The Authority processes personal data for the following purposes:
Additional information for application for Certificate of Airworthiness / National Air Authorization in accordance with EASA No. 216-2008

The legal basis for processing your personal data comes from:

Commission Regulation (EU) No 748/2012 of 3 August 2012 laying down implementing rules for the airworthiness and environmental certification of aircraft and related products, parts and appliances, as well as for the certification of design and production

Categories of personal data

The Authority processes the following categories of personal data on you:
Aircraft registration

The Authority discloses or gives your personal data to the following recipients:
Danish Transport, Construction and Housing Authority (TBST)

In connection with the oversight of the Danish Transport, Construction and Housing Authority, EASA (European Aviation Safety Agency) may require documents containing your personal data delivered as part of the audit. EASA is domiciled in Germany.

Storage of your personal data

Until 6 years after the aircraft has been removed from the Danish registry of Nationality, cf. Commission Regulation (EU) No 748/2012 of 3 August 2012 laying down implementing rules for the airworthiness and environmental certification of aircraft and related products, parts and appliances, as well as for the certification of design and production organisations

Your rights

The right to see your data
