

Agreed Minutes

1. The delegations representing the Aeronautical Authorities of the Government of the Sultanate of Oman and the Governments of the Scandinavian countries of Denmark, Norway and Sweden, respectively, met in Mumbai on 22 October 2011 during ICAN 2011, to discuss matters pertaining to air services between Oman and Denmark, Norway and Sweden. The discussions were held in a friendly and cordial atmosphere.

2. The list of delegations is attached at Attachment (1) and (2).

3. The delegations noted that Air Services Agreements (ASAs) had been initialled in 1999 in Muscat and that there was a mutual interest in modernizing and liberalizing these draft ASAs. In this regard, the Scandinavian delegation presented its model ASA, including e.g. certain EU aviation clauses and the inclusion of Norway in these clauses.

The Omani delegation responded that it has no major problems with this proposal and should study it further before submitting its final response.

4. Both delegations stated that they would consider positively any additional applications for 5th freedom traffic rights in the period before signing of the ASAs.

5. The delegations agreed to finalise the draft ASAs by correspondence or by negotiations at a time and venue to be agreed upon by the Aeronautical Authorities.
