

Application for TEMPORARY RVSM Approval

BACKGROUND (CASE REF 2022-055743)

TEMPORARY RVSM Approval full fill short term requirements of 965/2012 Part SPA, Subpart D but does not require long term requirements to be fulfilled.

Short term requirements: aircraft RVSM airworthiness approval, current accomplishment of RVSM maintenance requirements, crew capability and operating procedures.

Long term requirements: incorporation of RVSM maintenance requirements into operator's maintenance program and procedure manual, participation in height monitoring program, incorporation, incorporation of MMEL RVSM requirements into MEL.

The purpose of the temporary approval is to allow operators to fly in RVSM airspace during temporarily authorized flights i.e., flights conducted under Permit to Fly according to Part 21, subpart P.

CAA-DK will send this application form to the applicant of a PtF if a need for RVSM flight have been identified.

The temporary RVSM approval is granted when this form is signed by CAA-DK.

The temporary RVSM approval is reported by CAA-DK to Eurocontrol on form EUR RMA F2 where field RVSM expiry date is filled in.

The temporary RVSM approval is not provided to the operator directly. It is provided by CAA-DK via the PtF under conditions: "RVSM flight allowed provided no MMEL RVSM defects are released".

Completion of form:

- One application should be completed for each aircraft.
- · Attach referenced documents.
- Items marked with an asterisk (*) to be completed only for first aeroplane of each aeroplane type/model of operator's fleet.
